1. This Act may be cited as the Caribbean Community Short title. (Free Movement of Skilled Persons) Act.

2.—(1) In this Act—

Interpretation.

"Caribbean Community" means the Caribbean Community established by Article 2 of the Revised Treaty of Chaguaramas signed in the Bahamas on the 5th day of July, 2001 and includes the CARICOM Single Market and Economy;

"Caribbean skilled person" means any national who is recognized by the Minister as being a member or employee of a recognized organization or is the holder of a qualification or performs an occupation specified in the First Schedule.

"dependant" in relation to a national means—

- (a) the spouse of that national;
- (b) any unmarried child or step-child under the age of eighteen years of that national; and
- (c) any unmarried child under the age of eighteen years adopted by that national in a manner recognized by law;

"immigration officer" means any immigration officer 37/2004 appointed by the Governor-General under the Aliens Act;

37/2004 S. 29. "Member State" means a Member State of the Caribbean Community excluding an Associate Member within the meaning of Article 231 of the Revised Treaty of Chaguaramas;

- (a) is a citizen of a Member State; or
- (b) has connection with a Member State of a kind which entitles that person to be regarded as belonging to or, if it be so expressed, as being a native or resident of such a Member State for the purposes of the laws thereof relating to immigration;

"property" includes real and personal property;

- (a) in relation to Jamaica, the Minister responsible for labour in the form set out in the Third Schedule; or
- (b) in relation to any other Member State of which a Caribbean skilled person is a national, the competent authority of that state;

"recognized organization" means an organization declared by the Minister to be a recognized organization for the purposes of this Act by order published in the Gazette;

"spouse" includes-

(a) a single woman who has lived and cohabited with a single man as if she were in law his wife for a period of not less than five years immediately preceding the date of the application under this Act;

- (b) a single man who has lived and cohabited with a single woman as if he were in law her husband for a period of not less than five years immediately preceding the date of the application under this Act.
- (2) For the purposes of this Act, where the qualifying Caribbean Community state is Montserrat, a valid passport or other form of identification approved by the Minister showing the holder—
 - (a) to be a citizen of the United Kingdom and Colonies or a British Dependent Territories citizen; and
 - (b) to have been born in Montserrat,

shall be deemed to be issued in Montserrat.

3.—(1) Notwithstanding the provisions of any other law, an immigration officer shall, subject to section 5, permit a national to whom this section applies and any dependant of such national to enter and remain in Jamaica for an indefinite period.

Indefinite entry of Caribbean skilled persons, etc. 37/2004 S. 29.

- (2) This section applies to a national who—
- (a) holds a valid passport issued to him by a Member 37/2004 State or other form of identification approved by the Minister;
- (b) seeks to enter the Island for the purpose of engaging in or finding gainful employment with an employer or as a self-employed person; and
- (c) presents to the immigration officer upon entry into 27/2013 the Island a valid qualifying certificate.

Provisional entry of Caribbean skilled persons and dependants. 37/2004 S. 29. **4.**—(1) Notwithstanding the provisions of any other law, an immigration officer shall, subject to section 5, permit a national to whom this section applies and any dependant of such national to enter and remain in the Island for a period not exceeding six months.

(2) This section applies to a national who-

- (a) holds a valid passport issued to him by a Member State or other form of identification approved by the Minister;
- (b) seeks to enter the Island for the purpose of engaging in or finding gainful employment with an employer or as a self-employed person; and

(c) presents to the immigration officer upon entry into the Island a valid qualifying certificate.

Prohibited Caribbean skilled persons.

- 5.—(1) Subject to subsection (2), an immigration officer shall not permit a Caribbean skilled person or any dependant of such person to land in the Island if that person—
 - (a) is likely, if he enters the Island, to become a charge on public funds;
 - (b) is a person of unsound mind or a mentally defective person;
 - (c) is, on the basis of available information communicated to the Minister, suffering from a communicable disease which makes his entry into the Island dangerous;
 - (d) is, from information or advice, which in the opinion of the Minister is reliable information or advice, deemed by the Minister to be an undesirable inhabitant of, or visitor to, the Island; and

- (e) is a subject of a deportation order in force under the Deportation (Commonwealth Citizens) Act.
- (2) Notwithstanding subsection (1), the Minister may exempt any Caribbean skilled person from the provisions of paragraphs (a) to (e) of subsection (1).
- 6.—(1) A person who satisfies the requirements for re- Application cognition as a Caribbean skilled person may apply to the ing certifi-Minister for a qualifying certificate.

- (2) An application under this section shall be in such form and be accompanied by such fee as the Minister may, by order, prescribe.
- 7.—(1) Subject to subsection (2), the Minister shall Minister grant a qualifying certificate to every applicant who satisfies certificate the requirements for recognition as a Caribbean skilled to qualified person.

8. Notwithstanding the provisions of any other Act a Effects of Caribbean skilled person and every dependant of such person who are permitted to enter the Island under this Act shall not be subject to any restriction on-

- (a) freedom of movement, including the freedom to re-enter Jamaica without further leave and permission;
- (b) the freedom to acquire property for use as the residence or business of such persons; or
- (c) the right to engage in gainful employment or other occupation,

which would not apply if those persons were nationals of Jamaica.

Revocability of permission.

9. Notwithstanding the provisions of any other law, permission granted under this Act to a Caribbean skilled person to enter the Island and the rights conferred on that person under section 8 shall not be revocable except for cause and by procedure which would, apart from this Act, render a national of Jamaica liable to deportation, extradition or other form of expulsion from the Member State of which the Caribbean skilled person is a national

Offences and penalties.

- 10.—(1) A person commits an offence if—
 - (a) for the purpose of procuring a qualifying certificate or for the purpose of seeking permission under this Act to enter the Island, he—
 - (i) makes any statement, for himself or any other person, knowing such statement to be false in a material particular; or
 - (ii) recklessly makes any statement which is false in a material particular;

- (b) uses a certificate issued by the competent Minister of a Member State knowing that it has been cancelled by the Government of that state;
- (c) uses a qualifying certificate knowing that it has been cancelled by the Minister.
- (2) Conviction of an offence under this section shall—
 - (a) render a qualifying certificate liable to cancellation at the discretion of the Minister;
 - (b) render a permission granted under this Act revocable at the discretion of the Minister; and
 - (c) disentitle any person so convicted of the right to any permission under this Act.

(3) Any person who commits an offence under this Act shall be liable on summary conviction before a Resident Magistrate to a fine not exceeding one million dollars 27/2013 or to imprisonment for a term not exceeding twelve months or to both such fine and imprisonment.

11.—(1) The Minister may make regulations generally Regulations. for giving effect to the provisions of this Act and without prejudice to the generality of the foregoing may make regulations-

- (a) regulating the issue, amendment, revocation or replacement of qualifying certificates and for the payment of fees by the person applying therefor;
- (b) providing for the establishment and maintenance of a register of persons to whom or in respect of whom qualifying certificates have been issued, amended, revoked or replaced;
- (c) providing for the issue to any person who is exempt from any of the provisions of this Act a certificate stating the nature of the exemption;
- (d) with respect to the surrender or cancellation of any qualifying certificate issued by the Minister;
- (e) amending the First, Third and Fourth Schedules;

- (f) prescribing the forms to be used for the purposes of this Act;
- (g) prescribing any other matter or thing required to be prescribed under this Act.

- (3) Until varied or revoked by regulations made under 27/2013 this section, the regulations contained in the Fourth Schedule Fourth shall be in force.

The Caribbean Community (Free Movement of Skilled Person) Regulations, 2013

1. These Regulations may be cited as the Caribbean Community (Free Movement of Skilled Persons) Regulations, 2013.

Citation.

2.—(1) Every application to the Minister for a qualifying certificate pursuant to section 6(1) of the Act shall be in the form set out as Form 1 in the Appendix and shall be accompanied by the non-refundable application fee of two thousand dollars.

Application Form. Form1. Appendix.

- (2) There shall be paid in respect of the issue of a qualifying certificate, as regards-
 - (a) the applicant, a fee of eight thousand dollars; and
 - (b) each dependant, if any, of the applicant, a fee of two thousand dollars.
- 3. A qualifying certificate which is lost, stolen or destroyed, may be replaced upon payment of a fee of three thousand dollars.

Replacement of qualifying certificate. Amendment

4.—(1) Where there has been a change in the circumstances of a—

qualifying certificate.

- (a) Caribbean skilled person to whom a qualifying certificate has been issued (in relation to a dependant, such person being hereinafter referred to as the "primary holder"); or
- (b) dependant of the primary holder,

as a result of which the information appearing on a qualifying certificate issued to the Caribbean skilled person or in respect of the dependant of that person, as the case may be, or in the Schedule to a qualifying certificate, is no longer accurate, the Caribbean skilled person or the dependant of that person in respect of whom the qualifying certificate was issued, may apply in the form set out as Form 2 in the Appendix to have the relevant Form 2. qualifying certificate or Schedule thereto amended.

Appendix.

- (2) There shall be paid in respect of the issue of every amended qualifying certificate a fee of two thousand dollars.
- 5.—(1) The fee payable in respect of a qualifying certificate under regulations 2(2), 3 and 4(2) shall be paid in full before delivery of the qualifying certificate, into the appropriate account at any branch of a bank approved in accordance with the Financial Administration and Audit Act.

(2) An applicant who seeks to take delivery of a qualifying certificate shall submit to an authorized person the voucher issued by the bank specified

in paragraph (1), as proof of payment in full of the fee payable under these Regulations.

(3) In this regulation "authorized person" means a person appointed as such by the Minister for the purposes of the Act.

Verification of qualifying certificate issued by Member State.

- 6.—(1) Where a Caribbean skilled person is permitted to enter and remain in Jamaica under section 4 of the Act, that person shall within six months of the date of entry into the Island present his qualifying certificate and those issued in respect of his dependants, if any, to the Minister for verification of the validity thereof.
- (2) Verification of a qualifying certificate under paragraph (1) shall be made, free of charge, on presentation to the Minister of—
 - (a) the qualifying certificate of the Caribbean skilled person and those of his dependants, if any; and

Form 3. Appendix.

- (b) the completed verification data form in the form set out as Form 3 in the Appendix.
- (3) Upon completion of the verification process, if the Minister is not satisfied as to the validity of the qualifying certificate the qualifying certificate shall be deemed invalid.
- (4) Upon completion of the verification process, the Minister shall notify the applicant in writing, within a reasonable time thereafter of the outcome of the verification process, and in particular, whether the applicant's qualifying certificate is valid for the purposes of the Act.

Revocation or cancellation of a qualifying certificate.

7.—(1) The Minister may—

- (a) revoke a qualifying certificate issued under section 7 of the Act if he is satisfied that the person to whom the qualifying certificate was issued, at the time it was issued, did not satisfy the requirements for recognition as a Caribbean skilled person; or
- (b) cancel a qualifying certificate so issued if the person to whom it was issued has been convicted of an offence under section 10 of the Act.
- (2) Before revoking or cancelling a qualifying certificate under paragraph (1), the Minister shall notify the person to whom it was issued, in writing—
 - (a) specifying the reasons for revocation or cancellation; and

- (b) giving an opportunity to make representations, in writing, within-
 - (i) fourteen days; or
 - (ii) such longer period as the Minister may specify.
- 8.—(1) Where the holder of a qualifying certificate issued under section Surrender of 7 of the Act-

qualifying certificate.

- (a) ceases to be a national; or
- (b) is notified in writing of the revocation or cancellation of his qualifying certificate,

he shall, within thirty days after the date on which he ceased to be a national or the date of receipt of notification of cancellation or revocation, as the case may be, surrender his qualifying certificate to the Minister, as well as the qualifying certificates of his dependants, if any, available to him for surrender.

- (2) Where a person is granted a qualifying certificate by virtue of being a dependant of a primary holder on-
 - (a) ceasing to be a dependant of the primary holder;
 - (b) the primary holder ceasing to be a national; or
 - (c) cancellation, revocation or surrender of the qualifying certificate held by the primary holder,

that person shall surrender his qualifying certificate to the Minister.

- 9.—(1) There is hereby established a register of qualifying certificates Register. issued under section 7 of the Act or verified under these Regulations (to be known as the Register of Recognized Caribbean Skilled Persons) for the purpose of recording the-
 - (a) name of every Caribbean skilled person holding such a qualifying certificate;
 - (b) date of grant of the qualifying certificate held by that skilled person;
 - (c) names of any dependants appearing on the qualifying certificate; and
 - (d) particulars as to status of the qualifying certificate, including whether a certificate is valid, has been amended, surrendered, replaced, revoked or cancelled.

FOURTH SCHEDULE, contd.

- (2) The Register shall be kept by a public officer designated by the Minister as Registrar who may be assisted by such other public officers as may be duly appointed for ensuring the proper keeping of the Register.
 - (3) The Register shall be-
 - (a) kept at the office of the Ministry responsible for labour;
 - (b) open to inspection by any member of the public and a copy of an excerpt made available, upon request in writing accompanied by payment of such fee as the Minister may determine.

Offence.

10. Every person who contravenes regulation 8 commits an offence and shall be liable on summary conviction before a Resident Magistrate to a fine not exceeding five hundred thousand dollars or to imprisonment for a term not exceeding six months or to both such fine and imprisonment.
